7(a) 1037047 Ontario Ltd. - 1636 Drouillard Road - Lodging House - Class 1

Mr. Peter Barth on behalf of 1037047 Ontario Ltd., Mr. Vince Piruzza, Solicitor and Mr. Brian Craig, Business Manager are present to speak to this matter.

C. Robertson provides a historical overview of this application as follows:

- On October 2, 2015, Mr. Peter Barth submits an application for a new Lodging House Class I licence on behalf of 1037047 Ontario Ltd.
- Building Inspector, Eddy Staudt attended the premises at 1636 Drouillard Road on October 27, 2015 and met with Mr. Brian Craig who indicated he is awaiting a meeting with the architect to review plans for a reconstruction of the premises. Mr. Craig was advised to reschedule an inspection once a permit has been issued with approved plans for review.
- As of January 8, 2016, Inspector Staudt advises that to date the applicant had still not applied for a permit to undertake the necessary work at the premises.
- On January 21, 2016, the Licensing Department sent the application notification of non-compliance with the City's Building Department and Windsor Fire & Rescue Services.
- As of February 12, 2016 the applicant had not applied for a permit to undertake the necessary work at the premises.
- Fire and Rescue Services has not signed off on this application as they are awaiting the issuance of the permit.
- Eddy Staudt provides the following additional comments:
 - o There is a considerable amount of work being done on the 2nd floor of the lodging home. Advised Mr. Craig a permit is required.
 - o Viewed walls being closed up and the removal of fire separations.

o Essentially, work was undertaken without a permit and operating a lodging home without a licence. In 2010 there were nine rooms. The entire floor has been opened up and there are currently 26 rooms.

Mr. Peter Barth provides the following comments relating to this matter:

- o Visited the Licensing Division on five occasions. Has attempted compliance and states only one item is outstanding.
- o All outstanding items will be corrected within a few days.
- o Retained an architect to provide a rendering of the rooming house.
- o Alleges a representative from the Building Department indicated the site is not one of construction but of renovation.
- o People living on the second floor were removed. They were living there like "squatters".
- o States C. Robertson agreed to allow occupants in the home as the process for this matter was taking too long.
- C. Robertson indicates at no time, will the Licensing Division allow a lodging house to be occupied without a licence.
