6. Licence Transfers

(a) Transfer of Plate #130

Mr. Kamel Kakish, Transferor and Mr. Elvin Luci, Transferee are present and available to answer questions.

WLC4/2018 That the transfer of Taxicab Plate #130 from the partnership of Mr. Kamel Kakish and Mr. Rajaei Kakish to Mr. Elvin Luci **BE APPROVED** with the following conditions:

- Mr. Elvin Luci be given thirty (30) days from the date of this decision to submit a vehicle for inspection that complies with Schedule 5 to By-law 137-2007.
- Mr. Elvin Luci must submit a Plate Holder application and pay the applicable fee.
- Mr. Elvin Luci shall provide verification that full compensation has been made to the partnership of Mr. Kamel Kakish and Mr. Rajaei Kakish in consideration of the transfer of taxicab plate #130.
- Mr. Elvin Luci shall not lease the plate for a one year period as stated in Schedule 5, Section 21.3 of Licensing By-law 137-2007.

REQUIRED to retake the customer service portion of the Taxicab Driver Education Program by April 16, 2018; and, that the Licensing Department **BE ADVISED** in writing by Checker Cab once the training has been completed; and, that Mr. Misbahul Mishu Kabir make an appointment and meet with the Supervisor of Licensing and the Manager of By-law Enforcement by April 30, 2018;

AND FURTHER, that **SHOULD** another complaint be submitted to and substantiated by the City of Windsor By-law Enforcement Office, **THAT** the Taxicab Driver licence 17 145110, issued to Misbahul Mishu Kabir **BE** immediately suspended until the next regularly scheduled meeting of the Windsor Licensing Commission.

(b) Release of Taxicab Wheelchair Accessible Plates

- C. Robertson provides the following as it relates to the release of Taxicab Wheelchair Accessible plates:
 - The City of Windsor's current taxicab fleet consists of six wheelchair accessible taxicabs which are operated under two taxicab brokers being, Canadian Checker Cab and Windsor Cab.
 - If approved, the Licence Commissioner will release 15 Taxicab Wheelchair Accessible plates, which will first be offered to the individuals on the current Drivers' List. There are currently 57 individuals on the Driver's List.
 - In the event the Driver's List becomes exhausted or no interest is shown, the
 release of the remaining accessible plates will be extended to any individual or
 party within the municipality's current taxi industry.
 - Administration is seeking approval to have the requirements of Section 7.1 of Schedule 5 to Public Vehicle Licensing By-law #137-2007 waived for those in the taxi industry as part of this accessible plate release until December 31, 2018.
 - Administration will ensure that accessible plates are issued and distributed through a fair process such as a lottery. It should be noted that preference will be given to those interested parties who are not currently licensed as plate holders.

 Schedule 5 to Public Vehicle Licensing By-law #137-2007 prohibits the transfer of any new Taxicab and/or Taxicab Wheelchair Accessible plate and that they remain the property of the City of Windsor.

Walter Bezzina, General Manager, Vets Cab Company applauds the release of the Taxicab Wheelchair Accessible plates. He adds that if a plate(s) is released to an independent cab company, that the Licensing Department ensure that the colours of the taxicab are not similar to the colours identified with Vets Cab.
