An applicant may not be eligible if he or she:

- Resides outside of Ontario
- Has total income or assets in excess of legislated limits
- Resides with parents, is not financially independent and has no dependants of his/her own
- Is incarcerated
- Is a single person under the age of 16 without dependants
- Is a single person with no dependants of their own and in receipt of a student loan (OSAP) under the Ministry of Colleges and Universities Act, or the Canada Student Loan Act

If you disagree with a decision about your application, first discuss the issue with your caseworker. If you still do not agree, you can ask for a review of our decision.

To make your request, you must write a letter or fill out a *Request for Internal Review* form and submit the request to the local Ontario Works Office within thirty (30) calendar days of the original decision.

online in English or French - visit ontario.ca/socialassistance to start your online application. Available 24 hours a day, 7 days a week. (The website includes a section that can tell you if you might be eligible before you apply.)

By Phone – call <u>519-255-5600</u> to start your application over the phone. The hours of the call centre are Monday to Friday, 8:30 - 11:30 and 1:00 – 4:00.

If you do not have a telephone or a computer with internet access, you can come to one of our locations, either in Windsor or Leamington, where you may be given access.

After the phone contact or on-line application, a scheduled face-to-face interview will occur with a caseworker at the Ontario Works office.



Ontario Works



Ontario Works (OW) provides financial and employment assistance to people in temporary financial need. People receiving assistance through OW participate in a wide range of employment assistance activities that help them prepare for, find and keep a job.

Confidentiality

All information you provide is confidential and protected under the Municipal Freedom of Information and Protection of Privacy Act.

Documents Required

When you apply, be sure to have the following information that pertains to you and all other individuals on whose behalf you are applying (e.g., spouse, dependent children and dependent adults):

Identification:

- Proof of birth
- Social Insurance Number
- Ontario Health Card
- Immigration documents to confirm your status in Canada

Income:

- Employment income paystubs
- Employment Insurance
- Spousal support payments
- Any other income or benefits, such as:
 - o Boarder/rental income
 - Any benefits under the Canada Pension Plan (CPP)
 - Workplace Safety and Insurance Board (WSIB)
- Insurance benefits from any other source

Assets:

- 3 months of updated bank statements
- Registered Retirement Savings Plan (RRSP) documents
- Life insurance documents
- Vehicle ownership information
- Property ownership information
- Details about any other assets

Accommodation Costs:

 Such as rental or mortgage agreements, as well as the cost of utilities, taxes and insurance

Other:

- Marriage Certificate, Custody/Separation Agreement or divorce papers
- School enrolment information for dependents 16 years of age or older
- Void cheque (for Direct Bank Deposit)

Applicants Under the Age of 18

Applicants under the age of 18 may be eligible for assistance if:

- There are special circumstances that are determined when a family assessment is completed;
- The person's living arrangements are favourable in meeting the conditions of eligibility regarding education or training and employment; and

 The person is in attendance as a full time student in a school, educational institution or approved training program.

A sole support parent under the age of 16 may be eligible to receive assistance for their dependent child.

Temporary Care Assistance

The adult providing temporary care can receive Temporary Care Assistance on behalf of a child under the age of 18 if <u>all</u> of the following criteria are met:

- The child is in financial need
- The child is not a dependent under the Ontario Works Act or the Ontario Disability Support Program
- The adult providing temporary care does not have a legal obligation to provide support
- The adult providing temporary care does not receive compensation under the *Child and Family Services Act*
