Mayor and Members of Council

My name is Nate Hope. I'm a downtown resident and Vice-President of the Windsor Downtown Neighbourhood Alliance, (AKA Windsor DNA) a recently restarted organization of residents in the downtown core. I'm thankful for the work the administration and council, have put into this plan, especially Councillor Renaldo. As downtown residents, our group is hopeful and optimistic about the potential for positive change. We experience firsthand the challenges of downtown, but we also experience its joys.

We are encouraged by the city's proposal to increase mental health support. Many of the people that need this help the most are our unhoused neighbours. We know that help for those in need benefits everyone in our community. I'm also pleased to see funding for a by-law officer. We often face issues with broken windows and neglectful landlords. It's difficult to understand how people can let boarded properties sit for so long. We care deeply for our home and downtown is our home. It's true that there is a perceived lack of safety. But unkept buildings don't help make people feel safe because the environment feels abandoned, I hope these changes can help.

A new policy can only change some things. We need everyone to change their perspective, we need to shift the narrative of what downtown is. Downtown didn't suddenly become unsafe, this is the result of accumulation of stories. I would argue this is the result of Downtown not being seen as a neighbourhood. It became a destination *only* for parties and carried with it the reputation of being rowdy. It is the centre of social services and carries with it the reputation of *only* being the destination for less well-off people. It became developed and adopted the reputation of being dirty. I don't think these are true and I don't think we need to carry these reputations. I want to challenge these perceptions so we can love our downtown.

Overall, I support this plan as a good step forward even though I have concerns over the additional police funding and green light cameras. The only criticism I have, and this is a friendly criticism, we need to emphasize the importance of resident involvement to make this successful and sustainable. I don't believe minimizing residents was intentional, but the document's posture feels primarily business-oriented. We must remember that a neighbourhood is only as healthy as its residents. For example, the plan talks of helping businesses to engage people leaving events. Businesses could also engage the 16,000 residents living downtown already. I look forward to seeing the details of the plan work out in the future. These may seem like small things, but as we've come to learn, the little things matter. It will only help us in the end to strengthen the core.

To Mayor Dilkens and Members of City of Windsor Council,

The Windsor-Essex County Health Unit (WECHU) has a long history of collaboration with health sector partners to support residents, businesses, and social services in alignment with our vision of *Healthy People in a Healthy Community*. With that vision in mind, we are encouraged by the solutions offered in the *Downtown Windsor Revitalization Plan* and support any measure which improves public health and safety in our community.

The downtown core of the City of Windsor represents one of the highest need geographic areas in our region and one which our agency prioritizes in the implementation of the Ontario Public Health Standards. As a service provider with primary operations located at 1005 Ouellette Avenue, we are aware that there is an important balance which needs to be struck in the downtown core. Given this perspective and experience, there are a few key points I'd like to raise to council:

- Based on CBRE Windsor's market research, our downtown office vacancy rate is currently 41.6%. This is the highest of any major downtown in Canada and well above the national average of 18.4%. It is also well above comparable markets such as London (28.1%) and Waterloo (22.5%).
- In 2019, the downtown Windsor office vacancy rate was 20.4% and today it is 41.6% while Windsor's suburban office vacancy rate only increased from 10.2% to 11.0% over that same period.
- Our estimate of downtown Windsor's retail vacancy is conservatively 33% and likely much higher.
- All of this data suggests that our downtown commercial real estate market is in a crisis state. The core continues to lose high profile tenants every year with the most recent example being Sutherland, one of Windsor's largest office users. Without daytime office users, retail has continued to struggle with evening traffic, resulting in notable longstanding bar and restaurant exits as well. With many notable leases expiring in the years ahead, there is real risk of further erosion in the core if we don't act now.
- Having assisted countless companies considering relocation across Windsor, safety and security remains the number one reason companies either elect to leave downtown or not consider downtown at all.
- Safety and security are priority to starting the process of bringing commercial tenants back to the core, which the plan addresses. For downtown to be vibrant, we not only need people living in downtown, but we need the full "live, work, play" environment and the seven action items provide the compass heading for doing so.
