I understand that there may be some concern relating to the \$357 Million dollars which the federal government hoped to flow through the Province of Ontario under the National Housing Strategy to support your work.

I was disappointed to learn that Ontario has rejected the conditional approval of their most recent Action Plan, and is choosing to forego the funding.

I want to assure you that the full amount of this funding which was meant to flow through the Province will nevertheless be used to make investments in affordable housing and housing supports for the most vulnerable in Ontario, and will be delivered directly by the federal government.

As you are aware, this funding is a reimbursement to Ontario for funds already spent. So, it should not impact you in the delivery of services this year. I would hope that the provincial government will not pull funding from affordable housing in future fiscal years. You should not be penalized for their failure to meet obligations under bilateral agreements.

With or without provincial involvement, we will ensure that affordable housing and housing supports for the most vulnerable are provided to the communities and residents in Ontario who need it most. We will likewise continue to work with Ontario in the hopes that we can avoid a similar situation in future years of our agreement.

I would like to meet with you at a mutually convenient time in order to ensure we deliver the funding in a way that most effectively supports your work, and to resolve any outstanding questions you might have.

Thank you for all that you do to serve some of our most vulnerable community members. I look forward to chatting more soon.

I know there have been concerns raised about the future of the National Housing Strategy (NHS) following the federal government's previous decision to withhold both its funding over the remaining term and the funds already spent by the province through service managers on the federal government's behalf.

I want to assure you that the Province of Ontario will continue to fund the provincial portion of the NHS. We believe that service managers are best positioned to understand the needs of their local communities and this is why we have fought so hard to retain your role in the program.

I am aware that you have recently received a letter from Minister Fraser. After weeks of discussion, the minister has finally agreed with us on the important role service managers play in delivering housing programs on behalf of the province and our municipal partners.

I want to thank you for your achievements over the past five years. Together we have made extraordinary progress delivering and preserving affordable housing in Ontario. Through your efforts, we are already more than halfway to our target of making available more than 19,000 new affordable housing units. In addition, together we have surpassed the NHS target of renovating, restoring or rehabilitating 26,000 affordable housing units by more than 365 per cent, with more than 96,000 units upgraded. Many of these units would not be available to families without your efforts.

Undoubtedly, the federal government's refusal to reimburse the \$357 million that we have spent on their behalf will have a negative impact on service delivery. I want to assure you that we will continue to work with you to mitigate these impacts so we can provide the best possible services to the people we have the honour of representing.

Again, thank you for all your efforts as we work to deliver and preserve affordable housing across Ontario.

Dear Members of Windsor City Council:

Buried in Appendix A of StrategyCorp's January 2024 report "Downtown Revitalization Plan – Key Findings and Recommendations," it is noted that: "There is a perception that Windsor has not done a good job historically at retaining anchor institutions in the downtown core."

Unfortunately, this observation is not explored more fully in the body of the report.

The closure of the Ouellette Campus of Windsor Regional Hospital, and its replacement with an Urgent Care Centre (UCC), is a jarring example of a plan that will undo the much-needed efforts to turn Windsor's downtown around.

The language surrounding the facility being planned in Windsor is misleading, and diminishes the risk to the area. While the public has been repeatedly promised a "satellite emergency department," the small print indicates very clearly it is to be a UCC.

Early in the mega-hospital planning process, the community were invited to look at Brampton's UCC as an example of what we can expect in Windsor.

Built in 2017, it was located on the site of Brampton's aging downtown hospital. All hospital services were transferred to the new Civic Hospital, approximately 10km from the city's downtown core.

According to the facility's website, "Our *[UCC] provides care when your illness or injury isn't an emergency*, but just can't wait," (emphasis added). Under the <u>Frequently Asked Questions</u>, patients are advised:

When should I go to the Urgent Care Centre?

Our services are covered by a valid Ontario health card. Visit the Urgent Care Centre for illnesses or injuries such as:

- · sprains, strains or broken bones
- · allergic reactions or skin rashes
- · asthma attacks
- · minor burns
- · cuts that might need stitches
- · earaches or eye injuries
- · fevers, coughs and colds
- · infections
- · nose and throat complaints

Babies six months of age or younger should visit Osler's Emergency Departments.

Patients are told to visit the emergency department for care related to serious injuries, illness or conditions, especially if they are experiencing symptoms and have an existing chronic condition, including heart disease, kidney disease, or diabetes.

This is a far cry from the healthcare services provided to Windsor's downtown population today.

In April 2020, the UCC in Brampton closed its doors, "to help increase focus on high risk, vulnerable patients in the community during COVID-19."

It only <u>reopened 21 months later</u>, in December 2021.

For the thousands of residents of Windsor's downtown core who do not own cars, especially those who are elderly or have impaired mobility, such a loss of access to healthcare services will be catastrophic. It will also be extremely costly to mitigate.

A UCC does not meet the healthcare needs of Brampton's downtown population. It will not meet the often complex healthcare needs of Windsor's current downtown population. It will not meet the community's future healthcare needs if the city's core is strengthened as proposed.

I urge you to follow the lead of Brampton's mayor Patrick Brown. He has been working tirelessly for increased provincial funding "to bridge Brampton's health care gap; including the completion of the second hospital with a 24/7 emergency department and additional beds."

The importance of a hospital as an anchor institution goes far beyond the provision of a full range of healthcare services and overnight beds. An acute care hospital provides thousands of direct jobs, which in turn increases demand for area housing and ancillary businesses. The presence of an anchor institution provides the stability for smaller businesses to establish themselves nearby.

Shockingly - because of the size and scope of the project - the prospect of further hollowing out of Windsor's downtown core was not considered in 2015 when the location of the new hospital was decided upon. According to *The Windsor Star's* Anne Jarvis, Bob Renaud, Chair of the Site Selection Committee for the new hospital, acknowledged: "There was never one suggestion made that we had to consider hollowing out the urban core."

If the Ouellette Campus of Windsor Regional Hospital is replaced by a UCC as planned, this closure alone will seriously undermine the efforts envisioned in C 49/2024.

I urge Council to add advocating for maintaining full acute care hospital services in Windsor's downtown core to the Revitalization Plan. We need to do better, because, as Brampton discovered, it will be extremely difficult to reverse such a grave planning mistake after the fact.

Since 2010 DWCC has been living and working in the downtown core to cultivate grassroots initiatives that aspire to seeing downtown as 'a good place to grow up and a good place to grow old.'

During the last two decades the call for fiscal restraint has been prioritized over the call for investment in the downtown core. The Strengthening the Core Revitalization Plan is a positive step forward and DWCC is supportive of the initiative. Investment in the core is a win-win. It can build a safe and enjoyable experience for residents as well as strengthen the financial wellbeing of the city.

Our reflection on the seven strategies notes the initial actions are centred on the business district investing in an increase of policing, camera surveillance, and bylaw staffing. The balance of the strategies is inspiring but lack specific actions. Our concern is if the other strategies will be backed with ideas and dollars in the coming years? If funding is not considered in future City of Windsor budgets this initiative will lose steam and undermine confidence in the City Administration to persevere in the hard work of transformation of the neighbourhoods we love.

We acknowledge that no one group has the capacity to make the change necessary. All levels of government, private corporations, residents and philanthropists, faith institutions and not for profits have opportunity and responsibility to participate. We also acknowledge that someone has to step up and lead.

DWCC commits to participate in supporting and speaking into the ongoing proposal. Over the summer season DWCC will be conducting a series of conversations based on the Revitalization Plan within the downtown neighbourhoods. The goal is to collate ideas from local residents that will be presented to Councillor Agostino and the Mayor's Office.

As security cameras with monitoring are assisting at the Windsor Masonic Temple, they should also assist downtown as a whole, via implementation of "Project SafeStreets."

The Windsor Masonic Temple is protecting both the investments in and results of the "For The Next 100 Years" program.

In the same way, the *Strengthen the Core* plan will protect Windsor's downtown.

The Windsor Masonic Temple would welcome a new "tailored to Windsor police response model focused on sustained high visibility and collaborative cross-sectoral response, Windsor Police Service will use all approaches to promote lawful behaviour, and disrupt and intervene in open drug use, property damage, petty crime, and disorderly conduct [all issues the Windsor Masonic Temple is facing] in the downtown core."

- The lack of coordination and cooperation with the senior levels of government to address the housing needs of our vulnerable residents


The consultant's report highlighted the lack of true engagement with community partners. They documented a pervasive feeling that city administration does not listen to the advice that community partners provide.

Community hubs like H4 are not a Windsor invention. Other communities have used the model far more extensively than Windsor has. There is no plan for housing and caring for people on the street now. The H4 expansion and proposed housing has been dormant and the decision to expropriate land only underlines the precarious nature of the proposal. A five-year wait is excessive. When you compare Windsor's proposal to the plan that London is implementing, it is readily apparent that our plan is inadequate and falls far short of meeting the needs of our community.

If this proposal for the downtown is approved, we will be adapting a plan to criminalize homelessness. I think our city administration can do better if they are allowed to offer comprehensive solutions to the problems we face.

Family Services Windsor-Essex (FSWE) is pleased to provide our support for the implementation of the proposed Downtown Revitalization Plan. For the past ten years we have had the privilege of working with the City of Windsor to provide Homelessness Outreach Workers, primarily in our downtown core. More recently, we have supported the Windsor Police Service as it relates to the safety and security of those engaging in panhandling. In both instances we have gained first-hand knowledge of the concerns of businesses and residents in the downtown as well as a deep understanding of the needs of those without permanent housing.

Since the inception of the H4, Family Services has supported this critical facility that offers drop in programming for those experiencing homelessness. A key component of a comprehensive homelessness prevention and intervention program is the provision of a drop in facility. Our Outreach Workers work to encourage individuals to access programming at the H4 as we support people on their pathway to housing. Expanding the hours of operation of the H4 has been an important initiative and we commend the proposed plan for recommending the continued extension of the H4's hours.

It is our hope that as we continue to work together as a community that includes the collaboration of businesses, police, the City of Windsor and community agencies, residents will feel safer and confident in their downtown. The improvements to downtown include addressing the needs of those without permanent housing and those who live in poverty. Providing the right supports in a comprehensive manner is an important step in supporting all of our residents.

We recognize that social challenges are not incumbent on the Windsor Police Service to address alone. It is only by working together that we can build the type of downtown that is accessible for all.
