Dear Minister Lebel

On behalf of the Windsor Bicycling Committee {WBC}, we congratulate the Government of Canada on the 15 June 2012 announcement of an agreement for a new Detroit River international crossing. The WBC welcomes the prospect of the publicly owned bridge allowing for active transportation -notably walking and cycling- between Windsor and Detroit.

The US Final Environmental Impact Statement for the DRIC project [http://www.partnershipborderstudy.com/pdf/FEIS/Section%203.pdf] stated that:

"The new bridge over the Detroit River and the plaza will be engineered to accommodate bicycles and pedestrians. U.S. Customs and Border Protection and its Canadian counterpart {Customs and Border Services Agency) will determine whether this traffic is allowed. "

We urge you to help ensure that cyclists and pedestrians are in fact accommodated on the new bridge. At present there is no way for people on bicycles or on foot to cross the border. As shown by the success of the annual "Bike the Bridge" event - the only time every year that the privately owned Ambassador Bridge permits cyclists- there is demand for a cross-border cycling route. A cycling route over the new bridge would promote a more active, healthier population and a more environmentally sound transportation system in the Windsor-Detroit area. One the economic side, it would be a boon to the growing cycle tourism industry.

We look forward to your response and leadership on this issue.
