WINDSOR SENIORS ADVISORY COMMITTEE ANNUAL REPORT TO COUNCIL JUNE 2013. DRAFT

SAC extends greetings to Council and expresses its appreciation for receiving our sixth Report since our inception in 2007. We begin by confirming our mandate:

"To identify and report to the Mayor and Council on ways to enrich and enhance the health and quality of life of all seniors in this community".

In that context, we ask Council consider the following as we present our Annual Report:

1. in pursuing our mandate, how does SAC support Council's work serving Windsor's citizens??

2. Conversely, how does Council consult with SAC on issues that affect seniors??

3. How can SAC and Council be held accountable for carrying out our related duties and responsibilities?

These are not intended to be rhetorical but to allow SAC; a Council created and constituted committee, to more visibly contribute to our City's vitality and quality of life.

One year ago, Windsor was granted membership in the WHO Global Network of Age Friendly Communities. Commensurately, SAC embarked on a two year process to develop a 'three year action plan'.

This process was highlighted by SAC in conjunction with Administration and other community partners organizing a Senior's Forum in October 2012.

The primary outcome of the Forum has been the formation of an Age Friendly Windsor Network which meets monthly and will produce by August 2013 the 'Action Plan' to be submitted to the Mayor and Council for final approval in early 2014.

SAC held a 'Strategy and Priorities' session which identified the following:

- 1. To continue the AFW project supporting the City's own strategic plan to diversify the City's economy and to create jobs by:
- a) completing our 'action plan' as above,
- b) nurturing our partnerships through the AFW Network, and
- c) organizing and hosting a provincial Seniors Summit.

2. a) To actively undertake trade show and info fair participation and b) to organize (up to four) consultative meetings supporting the AFW project but also to seek input on issues of concern to seniors.

3.a) To seek Council and Administration support in providing SAC amended terms of reference (see Council Report 12694 Mar. 6, 2007, 'Establishing the SAC'),

b)SAC reiterates its request to have its membership reinstated to recognize its unique age and health considerations, so as to more effectively implement our strategy and fulfill our mandate.

4. To recommend establishing a 'seniors focal point' within Administration a) to which 211/311 callers can be directed for more detailed information and b) to proactively promote seniors services available in the City (timely info is the overarching need for seniors and care-givers).

I would like to acknowledge the support provided to SAC by Council though Councilor Ed Sleiman, by Administration and particularly Karen Kadour, and for our 'resource personnel' Janice Koval, Library, and Celia Southward and her colleagues at Parks and Rec.

In closing, I wholeheartedly thank the members of SAC for their continuing support and participation and for the passion which they bring to enhancing the health and quality of life for our City seniors.

- 1. Karen, please add to the agenda **"Global Age-friendly Conference, Quebec City".**
 - a. As a review, this conference is being held September 8-11 in Quebec City. It is a global conference of members of the Global Network of Age friendly Cities. As of this date, there is NO representation from Windsor scheduled to attend from either SAC or other community groups. This conference will not be in Canada again for a decade or so. Jill has applied to her employer, Canadian Mental Health Association, for funding to attend. The total cost of attending is anticipated to be approximately \$2000 (including airfare, hotel, tuition, meals, taxi transfers, etc). She has been informed that CMHA is not willing to fund the entire cost of this trip. They are willing to split the cost with SAC. I understand SAC has designated funds for other purposes but in order to entertain discussion on the matter, I submit the following motion:
