4. **PRESENTATIONS**

4.1 <u>Colour Selections</u>

Max DeAngelis, Ellis-Don/DeAngelis Joint Venture and Adam Fawkes, HMCA, Architects are present to provide information relating to the colour selections for the Family Aquatics Complex.

M. DeAngelis advises with the Mayor's help, vision and patience along with assistance from the Project Manager, funds were made available to render the façade as a more iconic structure. He notes the location of the Complex takes advantage of the vista riverfront corridor.

Adam Fawkes displays architectural drawings of the ground floor, natatorium, aquatic park change rooms, entrance and the atrium. He notes the base of the Complex is masonry brick and the basic volume of the exterior is comprised of horizontal metal panels, glass and mullions placed in a rhythmic pattern.

Further remarks are provided relating to the colour selections and the salient points of discussion include the following:

- A question is asked if the multi-coloured glass on the exterior of the Complex is distracting. M. DeAngelis responds the multi-coloured glass highlights and pulls all of the action out to the front of the building. The dynamics of the building would be lost without the multi-coloured glass. The multi-coloured glass exemplifies a bold, clean and playful exterior.
- A request is made for the Complex to have a "living room feel". Suggestion to avoid black/grey metallic palette as the exterior has a "metal feel".
- Opportunity to pull more wood grain in the interior.
- Suggestion lower urinals be installed in the male washrooms.

4.2 Theming Proposal

Max Weber, and Adam MacIntyre, Weber Group are present to provide information relating to the theming proposal. The following conceptual drawings of the various areas in the Complex are provided:

- Toddler cove
- Flow ride area
- Concession Stand Tropical Treats and the Lazy River with mobile manta rays, sand dollars and star fish
- Wave pool
- Iconic element for the Water Park (orientation point for families)

Adam MacIntyre provides samples of various stretch fabrics to be utilized throughout the area and he suggests using a theatrical light package to add illumination and colour throughout the fabrics.

In response to a question asked by Councillor Sleiman relating to the life span of the fabric, A. MacIntyre responds the fabric is machine washable and he notes this fabric has been utilized in other facilities for over 15 years and is still in use.

D. Sadler refers to the "Iconic Element" for the Water Park and notes as this was not part of the tender, there would be an upcharge of \$130,000. for this enhancement. O. Colucci indicates there is \$1.57 million left as unencumbered funds in the Contingency Fund.

Councillor Payne recommends administration provide a report for the next Family Aquatics Complex Steering Committee outlining the logistics of the "iconic element".

Moved by Councillor Payne, seconded by Councillor Valentinis,

That Administration **BE DIRECTED** to provide a report back regarding the affordability of the \$130,000 "iconic element" to be placed in the Water Park as an orientation point for families.
