5.3 Ernst Wilby House, 1567 Ouellette Avenue

- G. Katz, and J. Koski provide a twofold presentation regarding the Ernest Wilby House located at 1567 Ouellette Avenue. G. Katz highlights various business related activities and commitments that he has been involved with in the City of Windsor. G. Katz summarizes his request not to designate the property as the existing owners have exhausted all their business options with the structure and are seeking a demolition permit from the City of Windsor Building Department.
- J. Koski distributes a copy of a drawing, which includes lot dimensions and setbacks, circa 1964 for the addition to the address of 1567 Ouellette Avenue, <u>attached</u> as Appendix "A". He suspects this drawing was submitted in conjunction with the request for a building permit, which would develop into a funeral parlour location known as

Sutton Funeral Home. He notes the percentage of the new addition compared to the original building footprint and questions the increased size and alterations and those effects on the heritage value of the property.

The Committee inquires as to why there has been preventative upkeep to the structure and indicates to the Solicitor the integrity of the addition to existing structure was done with great respect to the building (i.e. roof trusses – old to new tied in). The mortgage holders respond to the Committee that they have no responsibility to improve the property.

The Committee notes its willingness to assist in a tour of the structure to make an evaluation location and offers to research sources and find a full set of drawings at the Royal Architecture Institute of Canada (R.A.I.C). A report dated January 5, 2011 along with Notice of Council Decision of Council meeting dated March 7, 2011 is <u>attached</u> as Appendix "B".

J. Calhoun requests to the Solicitor that the 60 days for Building permit demolition be suspended. The Solicitor notes that he would contact the Planner with a response to that request.
