Ministry of Health and Long-Term Care (MOHLTC)

### 1. Ministry Initiated Agreements

No new agreements upcoming or in process.

#### 2. Resident Quality Inspection -RQI 2017

No RQI to date for 2017.

#### 3. Ministry of Health Visits / Public Reports

No Ministry of Health inspections since the last committee of management meeting.

#### 4. Quality Improvement Plan and Mandatory Reporting stats

Huron Lodge continues to use an interdisciplinary approach to ensure the quality indicators are in line with the provincial average.

#### 5. Resident Family Satisfaction Survey

Huron Lodge is looking to revamp the survey to better capture accurate information from both residents and families. We will also trial a blitz survey this fall in an effort to increase the participation numbers.

### Commission on Accreditation of Rehabilitation Facilities (CARF) Accreditation

The survey in June was concluded with positive informal final remarks. Huron Lodge will receive an official statement and status of accreditation in the upcoming weeks. This will be shared with the committee in the next meeting.

## Ontario Association of Non-Profit Homes and Services for Seniors (OANHSS) / AdvantAge Ontario

No significant news to share at this point.

#### Local Health Integration Network - Erie-St. Clair LHIN

The integration took place - to date no issues noted in daily operations. There is a slight increase in reporting requirements in regards to Emergency Room visits as well as Behavioural Support Ontario.

#### **Huron Lodge Specific Projects**

Integrated Attendance at Work Program —The program continues at Huron Lodge and now more staff enrolled. Positive results are seen overall and we are hoping to be able to achieve further deficit reduction in regards to attendance as we go along.

#### E-MARS Solutions/Clinical Software

Huron Lodge has transferred into the new clinical software- Med-E Care in late February 2017.

A considerable change management process is under way for both health care registered staff and administrative resource staff as users of this new system.

The implementation of E-MARs is expected for early fall as this is a team effort between Huron Lodge, clinical software and pharmacy vendors and IT department with Commissioner overview. This electronic medical administration system will greatly assist in the delivery an appropriate medication delivery as well as an auditing tool.

### **EmpCenter**

The corporate/vendor team continues to work towards a fall roll-out.
