THAT based upon current market value gains experienced by the Arts Endowment Trust investment City Council DIRECT the City Treasurer to withdraw an additional amount of \$61,722 immediately to be charged to the Arts Endowment Capital project (7179003); and,

THAT City Council **APPROVE** funding of \$144,500 which will be available for use from the Arts Endowment Capital project (7179003) for this project; and further,

THAT, in the event that the other sources of funding are no longer available, that any shortfall with regards to the sculpture project **BE FUNDED**, as a first charge, from the 2020 minimum contribution of 1.5% to the Arts Endowment capital project.

Executive Summary:

Background:

Project History

At its January 27, 2010 meeting, the International Relations Committee (IRC) supported an initiative to erect a sculpture to honour the current Sister City relationships with the City of Windsor. The sculpture would act as the focal point in the Sister City Gardens section of Jackson Park, which was created as a result of the Jackson Park Master Plan review. The IRC received approval to erect a sculpture or monument in the park by way of IRC Committee Report 28, approved at the May 17, 2010 meeting of City Council pursuant to M152-2010.

Known as the "Twin Cities Monument Project," the project began as an art competition aimed at post secondary students studying visual arts or related disciplines beginning in 2010. The competition returned a disappointing result which prompted the committee to open up the competition to the community in 2011 and later through an Expression of Interest in 2012. These attempts also did not garner much interest or participation in the competition. Prior to the Expression of Interest in 2012, the committee approved increasing the funding levels from \$5,000 to \$15,000 toward the project in an effort to attracting greater participation. The committee committed greater funding to the project from their 2013 Budget at their September 26, 2013 meeting, where funding was increased by another \$10,000, bringing the total contribution to \$25,000.

Not finding a suitable entry through an Expression of Interest held in 2012, the committee contacted Laura Shintani, a local artist known to the committee to determine her interest in participating. Ms. Shintani was known to the committee as she had been previously selected by our twin city of Changchun, China to participate in their Annual Art Symposium, and furthermore had enlisted the assistance of the committee in 2012 in making contact with Fujisawa, Japan. Ms. Shintani forwarded a proposal for consideration, which was discussed by the committee at the March 18, 2013 IRC meeting. The original agreement proposed the City contribute \$25,000 plus \$1,000 received from the Korean Society, with the remaining cost of \$224,000 to be raised through fundraising efforts by the Artist.

The original plan for the "You + Me" sculpture was to create two wooden seven foot tall Windsor Chairs which would be covered in wax fingerprints moulded to the chairs. Once the chairs were covered in fingerprints, they were to be cast in bronze and then installed in Jackson Park.

The Community Public Art Advisory Committee also approved the sculpture at its May 1, 2013 meeting.

Discussion:

Since the agreement of 2013, Ms. Shintani has moved away from Windsor and is no longer interested in pursuing this project. Ms. Shintani has donated the incomplete project to the City. The City and the artist have entered a previously approved legal agreement which allows for another artist to complete the project.

Local artist Mark Williams has completed three large bronze sculptures that are or will be on display within the City of Windsor. They are: Four Generations located in Ford City, Tecumseh/Brock Monument located in Sandwich Town and the Hiram Walker sculpture to be located within Walkerville. Additionally he has completed large sculptures such as the 1812 sculpture on display in the Kings Navy Yard in Amherstburg. Mr. Williams is willing to complete this project with a design change should the corporation identify funding.

Due to the length of time the project was in storage, the wax fingerprints that were pressed onto the chair forms have melted and are no longer identifiable as children's fingerprints. Mr. Williams is proposing to engrave our Sister City names into the cast bronze Windsor chairs. This project will remain a Sister City project and will become a significant marker honouring Windsor's relationships within Jackson Park.

It should be noted that the artist work on the project would begin shortly after a legal agreement between the artist and The Corporation of the City of Windsor. Casting of the sculpture could potentially take place early in 2020 with the installation into Jackson Park occurring later in the year.

Risk Analysis:

There are no significant or critical risks associated with the recommendations in this report.

Resource Risks: There is a risk that an increase to the material costs to bronze the sculpture or to install it in Jackson Park occur. Administration will review all expenditures to mitigate this potential risk.

Timing Risks: Should there be a delay in starting the project, Administration believes the cost of the project will rise.

Financial Matters:

All cost estimates in this report are subject to tendering and actual pricing. Administration is projecting the costs of installation based on current project expenditures. Until the project is tendered, prices will not be finalized.

Funding Sources

In 2018, Council directed that a formal Arts Endowment Fund be established and further that a minimum of 1.5% of the annual investment yield be placed in a capital project (Arts Endowment Capital project ID 7179003). The intent of the establishment of a separate capital project was to hold the annual minimum accumulation of investment income which could then be accessed as a funding source for future art related components of a City project. In other words, funds would be transferred out of the Arts Endowment Fund into a capital project which would accumulated until such time as there is an identified arts expenditure. To date, \$41,250 was transferred in 2018, representing the minimum transfer of 1.5% of the 2018 investment yield and an additional \$41,528 is expected to be transferred in 2019 representing again the

minimum required transfer of 1.5%. As such a total of \$82,778 will be available as a funding source for this sculpture project by the end of 2019.

Council will recall that the principle amount of \$2,750,000 identified for the Arts Endowment Trust was placed in accordance with the *Municipal Act, 2001* in two mutual funds; Universe Bond Fund (80%) and Equity Fund (20%) administered by the One Investment Program. As at August 20, 2019, the balance in the Arts Endowment investment is \$2,993,911, an increase of 8.14% or \$225,387 over the starting balance as at January 1, 2019. This increase is largely attributable to increases in the market value gains of the units held.

Unlike other types of investments such as GIC's where a guaranteed yield is paid at time of maturity, any gains due to market value increases are not realized until such time as units are redeemed. At any measurement point market values may be higher or lower than the previous mark. The intent of the Arts Endowment Trust was to ensure that in perpetuity funds generated from investment yields would be available to support capital projects that have an arts related component. As such, preservation of the principle investment of \$2,750,000 is of upmost importance. However of equal importance is the realization of any yields as a result of substantial market value gains through the redemption of units at a time when market values are high. This mitigates against the risk that those yields are not available when the funds be required. The timing of when to realize gains can never be known with any certainty. Market values can continue to rise and/or market values can decline overnight.

In order to fund this project, an additional amount of \$61,722 will be required. City Council will need to approve the withdrawal as it is above the minimum transfer of 1.5% or \$41,528 which would otherwise be completed at the end of 2019. Administration is recommending that this withdrawal be completed following approval of this report in order to realize the increase in market values. The additional withdrawal of the \$61,722 would crystalize the market value gain experienced to date in 2019 and then be subsequently invested in a short-term guaranteed investment until such time as the funds are required for the sculpture project. The additional investment income can be used to offset any unforeseen costs.

This would leave a balance of \$2,890,661 remaining in the Arts Endowment investment with the One Investment Program. This balance would continue grow for the remainder of 2019 assuming that market values continue to increase. There is risk that at December 31, 2019, the market value per unit may result in a balance that is less however this risk would need to be considered in the context of market analysis information which indicates that over a long period of time increased returns and higher yields can be generated by mutual funds rather than guaranteed investments and the fact that a portion of the market value gain available as at the date of this report was realized through the redemption noted above.

As indicated above, funds in the amount of \$26,000 have been pledged from the Korean Society (\$1,000) and International Relations Committee (\$25,000) in previous years. Due to the delay in this project, should those funds not be available, Administration is recommending that any shortfall be funded, as a first charge, from the 2020 minimum contribution of 1.5% to the Arts Endowment capital project.

It should be noted that preliminary discussions with a local social organization has occurred which may result in a sponsorship opportunity. Should this materialize, funds required from the municipality would be correspondingly reduced.
