#### 4. Business Items

#### 4.1 Medical Supplies for Changchun, China

The Chair indicates although medical supplies were ordered to be sent to Changchun, China due to COVID-19, it was determined that the supplies would remain in the City of Windsor and be distributed to the city's frontline workers.

The City of Changchun contacted the City of Windsor in April 2020 with an offer to send 20,000 medical masks and to absorb the costs associated with the International shipping. A logistics company was contacted to determine if they could help facilitate the delivery of the masks however, the masks that they had available did not meet Canadian standards.

A similar situation arose with Guro, South Korea, (not one of our twin cities) who offered to send 10,000 non-surgical masks, which were not acceptable due to the types of masks available.

Moved by Councillor Sleiman, seconded by R. Haidar,

That the verbal update provided by the Chair regarding the purchase of medical supplies for Changchun, China due to COVID-19 and the decision to distribute the supplies to the City of Windsor frontline workers **BE RECEIVED**.

## 4.2 2020 Children's Art Exchange

- S. Gebauer states our contact in Gunsan, South Korea inquired about the 2020 Children's Art Exchange and asked that if the City of Windsor decided not to host the event this year, if we would consider sending children's artwork as they are planning to hold their exhibition at the end of this year.
- S. Gebauer expresses concern that the children's art could be collected, however, due to COVID-19, and the fact that many of our City facilities are currently closed, finding a space to display the drawings would be a challenge and we would have to get creative.
- R. Haidar suggests collecting children's art and placing it on a multimedia video to share withe the community and with our twin cities, which would demonstrate the sister city relationships and that we're all in this together.
- D. Ableser proposes the IRC work with Communications to undertake a 3D video. S. Gebauer to contact Communications and to report back to the IRC.

Moved by R. Haidar, seconded by D. Ableser,

That the 2020 Children's Art Exchange **MOVE FORWARD** and that Administration **BE REQUESTED** to report back on the feasibility of creating a Virtual Children's Art Exchange for 2020.

- S. Gebauer indicates at the February 26, 2020 meeting, the IRC was provided with photos of "Sister City Posts" located in Los Angeles and San Francisco. There was discussion on the possibility of erecting something similar on the City Hall Campus, which would display the names of our twin cities. The Parks and Traffic Departments were consulted on the potential of designing and creating the Twin City Post and an estimate of \$14,000 was quoted.

Councillor Sleiman states as a false accusation has been made, it would be appropriate to respond to the complainant.

Councillor Kaschak advises that as the complaint was initially sent to the Mayor's Office, it would be fitting to follow-up with the Mayor's Office. S. Gebauer to contact the Mayor's Office on this matter.

# 5.5 E-mail from Jerry Barycki regarding the 20<sup>th</sup> Anniversary of the Twinning Relationship between Lublin, Poland and the City of Windsor.

J. Barycki states June 26, 2020 will mark the 20<sup>th</sup> anniversary of the twinning relationship between Windsor and Lublin, Poland. The two decades of well-documented, active cooperation have been very productive. For the 20<sup>th</sup> Anniversary, they have prepared an exhibition, which will be in the form of an electronic document. S. Gebauer to work with Communications to ask if the electronic document can be displayed on the City of Windsor website and to assist with a display at City Hall at a later date.

# STRENGTHENING OF COOPERATION IN THE POST-CORONAVIRUS ERA AND PROMOTION OF THE DEVELOPMENT OF CITIES

# JOINT POLITICAL DECLARATION WITHIN THE SCOPE OF THE VIRTUAL MAYORS' SUMMIT IN MANNHEIM

We, the political representatives of the cities of Mannheim, Berlin Charlottenburg-Wilmersdorf, Beyoglu, Bydgoszcz, Chi inau, Klaipeda, Riesa, Swansea, Toulon, Windsor and Zhenjiang, allied through partnerships and friendships between cities,

who have met on 9 September 2020,

in the 75th year after the founding of the United Nations,

for a virtual conference,

#### recognise

that the United Nations was founded as the world community's reaction to the devastation of two world wars and with the aim of maintaining world peace and the economic and social progress of all peoples;

and

that the United Nations, like no other organisation, stands for the concept of a multilateral, rule-based world order;

#### determine

that the aims of the United Nations, especially the creation of a peaceful world, respect for human dignity, the equality of genders and a good standard of living for all people, are still of unchanging relevance and have not been achieved to the required extent in the 75 years of the existence of the United Nations;

that armed conflicts and political oppression as a reason for flight and expulsion represent major obstacles to sustainable development and that the community of nations, in adopting the Sustainable Development Goals, has committed itself to creating and permanently protecting peace and justice;

that today the majority of people live and work in cities and that the growth of the urban population will persist steadily in the coming decades;

that the achievement of the objectives that the community of nations has adopted in the area of sustainable development, especially the Paris Agreement to combat climate change and the Sustainable Development Goals, will only be successful if implementation is at local level;

that we must undertake efforts to pursue green, low-emission development;

that many cities have already initiated ambitious transformation processes to facilitate the protection of natural resources, a responsible economic system and socially just development with the desire to ensure in this way that no-one is left behind;

that the coronavirus pandemic has hit all cities hard worldwide, led to the severest levels of death and illness, involves severe cutbacks for many businesses and their employees and has caused considerable losses of revenues for many cities, made public life and the exercise of the most diverse forms of culture more difficult and presented financially weaker cities in developing countries with sometimes insurmountable problems;

that people form a community with a common goal and that we can only tackle the various global risks and challenges facing us through our concerted efforts;

that the City of Mannheim and its partnership and twin cities have shown and experienced solidarity in the coronavirus pandemic and that worldwide there are countless examples of how cities have helped each other across the borders of countries and continents in times of crisis and thus made a real contribution towards overcoming the crisis;

#### and declare herewith

that it is the urgent wish of the citizens of our cities and their legitimate political representatives that the national governments that are the sole representatives on the Security Council of the United Nations and that have the power to make decisions about war and peace should increase their efforts to end armed conflicts and to combat all causes of flight and expulsion, including human-made climate change, to an extent leading to an actual improvement in the living situation of all people in crisis areas;

that the institutions and bodies of the United Nations should be equipped by the national governments with all necessary financial and personnel resources to fulfil their important tasks;

that the provision of financial aid programmes for the cities to overcome the coronavirus crisis by the national states and international organisations is correct and important, but that what counts, when these are implemented, is that the transformational processes that have started should be speeded up rather than slowed down;

that the cities within the system of the United Nations are important partners for the maintenance of a multilateral, rule-based world order and therefore must be permanently integrated into the processes and structures for the further development of multilateralism;

that the achievement of the goals of the community of nations, especially in the area of sustainable development, can only succeed through a redefinition of the role of the cities within the United Nations system and there is therefore a need for an institutional reform of the United Nations which will lead in the end result to a formalised participation of the cities in the decision-making processes of the United Nations;

and that it is our common will, especially as a consequence of the coronavirus crisis, to continue and further intensify our international collaboration within the framework of city networks and partnerships, project cooperations and the shaping and implementation of global political agendas with the close integration of the citizens of our cities and using the technical progress made in digitisation with the aim of achieving a peaceful, fair, sustainable world.

IN SUPPORT OF THE GLOBAL CONVERSATION HONOURING THE 75TH ANNIVERSARY OF THE UNITED NATIONS

**SHAPING** 

2020 AND EYOND

On behalf of Mayor Dilkens, Windsor City Council and our International Relations Committee, it is an honour to be invited to speak with you, to adopt a joint declaration relating to the future of the United Nations.

Today, I will discuss international cooperation between cities and will share our storied relationship with our American neighbours in Detroit, Michigan. Windsor and Detroit are separated by the Detroit River, but are connected by an international bridge and a tunnel. A second span, The Gordie Howe International Bridge, which is currently being built, is the largest shared infrastructure project between Canada and the United States.

Windsor and Detroit share a very busy border crossing. On average, 15,000 cars and 8,000 trucks cross our border every day, which equates to 1/3<sup>rd</sup> of all surface trade, or half a billion dollars between our two countries.

Moreover, approximately 7,500 individuals cross the border daily for work in the Healthcare, Education and Automotive sectors.

Our region is now home to Canada's highest concentrated automotive cluster, which borders America's Motor City in Detroit. Beyond automotive and manufacturing, there are many other examples of bi-national cooperation. For instance,

- Transit Windsor operates the only cross-border public transit system in North America;
- The Windsor-Detroit tunnel is co-owned by the cities of Windsor and Detroit;
- The Windsor-Essex Regional Chamber of Commerce and the Detroit Chamber of Commerce offer cross-border membership;
- And, Hacking Health Windsor-Detroit, pairs innovators with healthcare experts to build solutions to healthcare problems through the use of emerging technology.

Furthermore, Tourism is vital to our shared success. American travellers account for almost 40% of visitation and almost 40% of spending in the Windsor region. Gaming accounts for 50% of all activities and in fact, 1/3<sup>rd</sup> of all business at Caesars Windsor Casino Resort is from American clientele.

Travellers also visit parks and gardens, attend festivals and sporting events and spend their money on recreation, entertainment, food and beverage, retail and accommodations.

Through the years, the marketing of a "Two-Nation Vacation Destination" has become a popular theme for both our cities. Large-scale events, such as Super Bowl 40, the Detroit Grand Prix, Red Bull Air Races, the Detroit Free Press Marathon, the North American International Auto Show, and the Ford Fireworks have been able to capitalize on the connectivity between both countries.

Today, however, due to the COVID-19 pandemic, we live a new reality.

In March, the Governments of Canada and the United States instituted a temporary 30-day restriction on all non-essential travel at the Canadian-American border. This restriction has been further extended to late September and possibly beyond.

The border restrictions obviously resulted in a steep decline in both trade and traffic. However, cross border cooperation was necessary to enhance public safety. In fact, the pandemic has highlighted the importance of our cross-border cooperation more than ever, as thousands of Windsorites work in Detroit. The border remains open for essential workers, such as truck drivers who are crucial to maintaining our integrated supply chains and overall economic well-being. This pandemic has reinforced the importance of a strong cross border relationship with our neighbours in Detroit.

The reality, which we face today because of the COVID-19 pandemic has forced us to quickly shift from normal to something completely different in order to respond to the needs of our community. Windsor has worked closely with our neighbouring municipalities over the past several months and together, with senior levels of government to ensure the public's safety.

Our goal is to continue to strengthen our international cooperation by sharing our experiences with other jurisdictions so that we are better prepared in the event of a second wave of COVID-19, or perhaps a different virus or situation that may arise in the future.

Our many lessons, our successes and our failures must be shared. While navigating this pandemic we have worked to ensure that cross border trade resumed quickly and that the health and livelihood of our citizens was not compromised.

While continuing our day-to-day operations, the safety of our community has been our number one priority. The City of Windsor will continue to do what is required for the wellbeing of our community, the success of local businesses, and of course the continued mutually beneficial relationship with the City of Detroit.

We look forward to sharing our lessons, our knowledge and expanding on our awareness through more communication with other cities, both local and international.



Dear Mr. Mayor,

We the members of the Tigray Community of Windsor and Essex County who are Canadian citizens seek your immediate assistance regarding the dangers and threats happening and looming against our people of origin, Tigrayans in Ethiopia, spearheaded by the current prime minister of Ethiopia, Mr. Abiy Ahmad and his government. Tigray and its people as one of the eleven regional states of the Federal Democratic Republic of Ethiopia have contributed to its development and have paid the highest sacrifice in defending their country's sovereignty. The Tigrayan citizens of Ethiopia along with their compatriots have fought generations after generations to overthrow the totalitarian and rouge governments of Ethiopia, and finally were successful in establishing a federalism which grants full rights of self-determination of all nations and nationalities of Ethiopia on February 22, 1987.

The prime minister of Ethiopia Mr. Abiy Ahmad and his government who took power in April 2018 have aimed at subjugating the people of Tigray against their constitutional rights, and engaged themselves in such countless dreadful political encounters, just to mention but a few, are the following:

- 1. Repeatedly provoked genocidal attack against them by
  - Blaming the Tigrayan citizens of Ethiopia as the only root-cause of all the political problems of the Ethiopian people.
  - Spreading venomous lies and creating fake documentaries and broadcasting them on the publicly funded media outlets such as ETV, WALTA, FANA, AMAHRA MASS MEDIA.
  - Holding televised hate speeches by the prime minister himself and assigning aversion names to leaders, scholars and politicians of Tigray as "Day Light Hyenas".
- 2. Intentionally punished the people of Tigray economically by
  - blocking the main highways linking the regional administration of Tigray with the rest of the country for over a year and half.
  - Cancelling developmental projects particularly that of Tigray regional state such as railway lines and industrial parks which were initially planned by the federal government before the prime minister came to power.
  - Refusing foreign investors who were interested to invest in Tigray by not allowing them to travel to Tigray
  - Intimidating domestic and foreign travelers, scholars and politicians who are interested to travel to Tigray for business and tourism.
  - Threatening to cut the budget and the power supplies, and close universities of Tigray.

- 3. Created psychological anxiety, instability and constant fear against Tigrayan citizens by
  - Arresting high ranking members of the military, successful businessmen, politicians and journalists of Tigray origin who have been bravely serving their country.
  - Denying justice to the families of those heroes who fought for their motherland, general Seare (the then Ethiopia's chief of staff) and general Gezaee who were assassinated while they were actively serving under the command of the prime minister.
  - Encouraging the political elites of the neighboring administrative region and country to engage in a conflict with the people of Tigray and possibility create a civil war against them.
  - Threatening Tigray and its people to be subjected to a war if they exercise their constitutional right, holding the 2020 election as scheduled. The prime minister, Mr. Abiy Ahmad was heard as saying in a publicly broadcasted speech that "we don't want to see houses burned, mothers cry and young people die" If Tigray hold elections. Those are the prime minister's words against his own people. (A prime minister who once was a Nobel laureate and has gone on a streak of political loss day by day.)
- 4. Cut off media outlets and tele-communications of Tigray using their federal powers by
  - Blocking Tigray TV, Dimitsi Weyane (DW) and channel 29 TV stations
  - Cutting off the internet for unlimited time, in Ethiopia where there are 110 million people.

Currently, Ethiopia is in a political turmoil. Based on Ethiopian state media, it has been reported that the government security forces have killed more than 230 young citizens (mostly Oromos) while protesting the assassination of a well-known Oromo nationalist singer, Hacchaluu Hundessa. In early November 2019, more than 86 people were killed by the government security forces in Addis Ababa and its environs while protesting the government. In May 2019, in a statement issued by Benishangul Gumz regional party, it was indicated that more than 200 civilians who are ethnically Gumuz and Sinasha were brutally killed by the regional government's armed group including kids, elders and mothers. Thousands of innocent civilians from the *Kemant, Tigray, Oromo, Guji, Afar*, etc. were killed in the last two years by the government security forces.

Extreme human rights violations, mob justice and lawlessness, and displacements of citizens are happening now in Ethiopia in unprecedented way. Last week, most prominent opposition party leaders in the country were arrested. TV stations which were the voices of the people of nations and nationalities were shut down. It has been almost two weeks since the internet is cutoff. The prime minister of Ethiopia has suspended Election 2020 indefinitely using COVID -19 as an excuse. He breached the constitution repeatedly so he could be in power illegally for an unknown time even though his term expires in October 05/2020. Moreover, he has orchestrated a wide range of campaigns against the people and government of Tigray administrative region, and repeatedly threatened that he will declare war against them if they hold election according to the constitutional deadline.

We kindly ask you to be the voice of the Tigray people who are running an uncertain life due to the threat of war and genocidal attack orchestrated by the prime minister, Abiy Ahmad, and the federal government of Ethiopia for exercising their constitutional right. We hope that you will impose pressure against the government of Ethiopia so it can hold civilized dialog with the opposition parties of the country to come up with political solution for sustainable peace.
