We are counsel to CTC, owners of the 113 properties (the "Properties") to which the above-noted Orders relate. Enclosed please find CTC's Notices of Appeal from the Orders pursuant to section 15.3 of the *Building Code Act, 1992*, S.O. 1992, c. 23. Please also find enclosed a certified cheque in the amount of \$39,663.00 payable to The Corporation of the City of Windsor, in respect of the required appeal fees (113 appeals x \$351 per appeal).

Each of the Orders states that the subject Property "[d]oes not conform to the standards set forth in By-law Number 147-2011 as amended by By-law 213-2011". The Orders further purport to require CTC "to do the work required to repair the defects set forth in this Order and make the said property conform to the standards set forth in the said By-law".

CTC's position is that the Maintenance and Occupancy By-law (the "By-law") does not apply to the Properties, as CTC is a federal undertaking. The City of Windsor has previously acknowledged this to be the case. CTC intends to challenge the applicability of the By-law to the Properties. CTC nevertheless files the enclosed Notices of Appeal out of an abundance of caution, and without prejudice to, and while fully reserving its rights to, challenge the applicability of the By-law to the Properties.

The grounds for CTC's appeals are set out in the Schedules below. Set out in **Schedule "A"** are the grounds of appeal relating to the 82 Properties for which the applicable Order does not contain an alleged defect pursuant to the Heritage provisions of the By-law. Set out in **Schedule "B"** are the grounds of appeal relating to the 31 Properties for which the applicable Order does contain an alleged defect pursuant to the Heritage provisions of the By-law.




