6. BUSINESS ITEMS

6.1 Share the Road Cycling Coalition Bicycle Friendly Community Designation

Councillor Halberstadt distributes his e-mail-dated October 11, 2011 relating to the "Go for Silver Campaign", <u>attached</u> as Appendix "A". He refers to the following six points in the Go for Silver Campaign outlined by the Share the Road Coalition CEO Eleanor McMahon:

- Lack of full-time staff attention
- Need bike parking inventory for office, retail locations
- Percentage of arterial streets with bike lanes network needs work
- Expand in-school bicycling education and regular education for adults
- Consider a Bike Sharing Program
- Collision analysis

Councillor Halberstadt indicates there is a need for a dedicated staff person to pursue the silver designation. He suggests that an investigation be undertaken to determine if other municipalities of similar size to Windsor have a dedicated bicycle coordinator.

Hi Everyone:


As promised at our informal meeting last week, here are the six points in the Go For Silver Campaign as recommended by Share The Road Coalition CEO Eleanor McMahon when she presented the Bike Friendly Community bronze medal to City Council:

- Lack of full-time staff/attention.
- Need bike parking inventory for office, retail locations
- Percentage of arterial streets with bike lanes network needs work.
- Expand in-school bicycling education and regular education for adults
- Consider a Bike Sharing program
- Collision analysis

I spoke to Eleanor last week at the Essex County Active Transportation Conference and she promised to advance within the next month, prior to 2012 budget deliberations, a more detailed benchmarking in the Go For Silver Campaign based on the city's application to the Coalition and the analysis of it by the judging panel. Needless to say, we will need the input of traffic engineering management to attach a cost to any of these improved initiatives.

Kari Gignac's analysis of the shortcomings in achieving BUMP" milestones with regard to arterial streets should be helpful.

In accordance with the approved procedures contained in the Municipal Engineers Association's Municipal Class Environmental Assessment, the Essex Region Conservation Authority (ERCA) and City of Windsor are proceeding with the Grand Marais Drain Channel-Improvements (Dougall Avenue to west of Huron Church Road) Class Environmental Assessment.

The existing concrete-lined portion of the Grand-Marais Drain (generally between Dougall Avenue and Huron Church Road) was identified in a recent study to be oversized and in need of substantial repairs. In 2010, ERCA commissioned a follow-up study aimed at identifying alternative channel designs for an improved Grand Marais Drain with an emphasis on establishing a more sustainable, ecologically desirable and aesthetically-pleasing flood-control channel. The purpose of this Class EA will be to assess these alternatives in consultation with the public and to select a preferred solution.

The following Problem/Opportunity Statement has been established for the project:

"In order to maximize the potential benefits to the surrounding community, this study will identify alternative means and measures for restoring the concrete-lined segment of the Grand Marais Drain; with a focus on exploring the potential for establishing improved connections between the communities on either side of the Drain, and for making recreational, aesthetic, and habitat improvements within the channel corridor."
