He notes Mr. Lesperance filed a "renewal" application but the former licence cannot be dealt with retroactively.
- M. Chantler states he received a further request for deferral from Mr. Lesperance's legal counsel.
- M. Chantler notes a re-inspection of the property will be undertaken prior to the issuance of the licence.
- Mr. Lesperance indicates he is in compliance with the Business Licensing By-law and there are no longer any issues.
