# 7(a) <u>2261203 Ontario Inc. o/a Text Rom Canada – Automobile Service Station – Leasing and/or Renting of Vehicles</u>

Mr. Julian Aftim, applicant is not present.

Mr. Rodney Roehler, Shop Supervisor, Text Rom Canada is present and requests to speak to the matter.

M. Chanter advises it is at the discretion of the Windsor Licensing Commission to allow/disallow Mr. Roehler to appear as a delegation on this matter.

That Mr. Rodney Roehler, Shop Supervisor, Tex Rom Canada BE PERMITTED
to appear as a delegation on the matter relating to 2261203 Ontario Inc. — Automobile
Service Station — Leasing and/or Renting of Vehicles.

- M. Chantler provides the following sequence of events relating to this application:
- On November 20, 2012, Mr. Aftim attended the Licensing Division to make application and was advised to contact the Planning Department regarding the zoning prior to making the application. Mr. Aftim did not heed the advice and made application.
- On November 27, 2012, the Zoning Coordinator, City of Windsor denied the Automobile Service Station application as the property is not zoned for an Automobile Service Station-Leasing and/or renting of vehicles.

Mr. Rodney Roehler is requesting an extension of time to allow the applicant to undertake the rezoning of the property.

M. Chantler indicates as the zoning change has not been addressed since November 2012, the property has essentially been "in limbo". He notes once the applicant applies for the zoning change, a new application is required.

In response to a question asked by Mr. Roehler, if they will have to cease operating the business, M. Chanter responds the applicant may continue operation as a Automobile Service Station however, renting and leasing of vehicles is not permitted.

Moved by Councillor Dilkens, seconded by Councillor Hatfield, WLC6/13 That an extension of time to July 27, 2013 BE GRANTED to allow for the applicant Mr. Aftim, Owner of 2261203 Ontario Inc. o/a Test Rom Canada located at 2-4050 North Service Road, Windsor to submit the necessary materials required for an application for rezoning, failing which, the application will BE REFUSED.

## 7(b) Riverside Rickshaws - Livery Licence - Class "E" Pedicab

Mr. Julius Wamala, applicant is present and available to answer questions.

M. Chantler succinctly provides the following as it relates to the application:

- On May 27, 2013, an application submitted by Julius Wamala for three (3) new Livery Vehicle licences was received by the Licensing Division.
- Mr. Wamala submitted all licensing requirements with the exception of a Vehicle Permit issued under the *Highway Traffic Act* and a Safety Standards Certificate for each vehicle. It should be noted that the Province of Ontario does not issue Vehicle Permits or Safety Standards Certificates to pedicabs or rickshaw carts. Therefore, an applicant for a Class "E" Livery Vehicle licence would be unable to comply with such requirements. As such, Administration is suggesting that in order to approve Class "E" Livery Vehicle applications, that the By-law would require an amendment (Section 4.2 of Schedule 3 to Public Vehicle By-law 137-2007 to be amended to exempt vehicle permits issued under the *Highway Traffic Act* and safety standards certificates as licensing requirements for future Class "E" Livery Vehicle applications).

Moved by J. Fathers, seconded by Councillor Hatfield,
WLC7/13 That Riverside Rickshaws (Julius Wamala), new application to operate
three (3) Livery Vehicles, Class "E" – Pedicab BE APPROVED and further that,

Section 4.2 (b) and (e) of Schedule 3 to Public Vehicle By-law 137-2007 BE AMENDED to reflect the exemption of Vehicle Permits issued under the Highway Traffic Act and Safety Standard Certificates as licensing requirements for Class "E" – Pedicab Livery Vehicles.
