If a Proponent proposes another form of performance bond, it shall propose the alternative form following the process described in section 4.1 of these Instructions to Proponents. The digital agreement to bond/surety's consent shall remain valid for at least the duration of the Irrevocability Period.

Except for the contents of this addendum, all other terms and conditions of this proposal remain the same.
