REVISION TO SPECIFICATIONS:

11. SITE INVESTIGATION BY PROPONENTS

- Section 11.2: Further to the wording in section 11.2 the following shall be added to this section: "Should proponents wish to gain access to CN property, then flagging protection will be required. To accommodate this, 1 day will be selected where CN can provide protection and any potential proponent can check in and gain access to the property."
- Section 11.8: Broad form Commercial/Comprehensive General Liability insurance shall have an inclusive limit of not less than \$10,000,000.

APPENDIX "B" – TECHNICAL SUBMISSION REQUIREMENTS

Technical Submission Stage 1

- Section 4 Proponent Experience
 - o 1.1.2: The text shall be changed to the following: "The proponent has successfully completed similar structural works within the last 5 years within an active rail corridor. Construction of a rail underpass structure is an asset".

Technical Submission Stage 2

- Section 1 Schedule
 - 2: Please note the following to be added to this section: "Time will also have to be allocated for signal work (protection of CN utilities) and track construction (removal/installation of track panels)."

Except for the contents of this addendum, all other terms and conditions of this proposal remain the same.
