This addendum amends and forms part of the Tender Documents. The Bidder shall insert the addendum behind the cover page of the Tender Documents.

QUESTIONS AND ANSWERS

- Q#1- How is the contractor to include duct sealing, if there is no non-destructive method to quantify/ verify scope of work? Can allowance be considered?
- A#2- Total Tender Price (Base bid) to include 200 lineal feet of duct sealing. Provide Add/Deduct Unit Price per foot of duct sealing to be applied against quantity carried in Total Tender Price (base bid). All duct sealing to be documented or verified with City of Windsor Representative- See revised Bid Form attached.
- Q#2- What is required colour of "FlexClad-400" product?
- A#2- Almond
- Q#3- Can materials & equipment be stored on site?
- A#3- A designated exterior material & equipment storage space will be made available according to attached sketch. Security of materials & equipment is the responsibility of the contractor.
- Q#4- Proposed Alternate to "FlexClad-400" as 3M Venture lad
- A#4- Total Tender Price (Base bid) to reflect specifications. Alternate Price to be provided to Substitute "3M Ventureclad 1579GCW-WME White, Embossed" in place of "FlexClad-400"- See revised Bid Form attached.
- Q#5- Proposed Alternate to replace all "D1" type insulation with Mineral Wool type insulation with kraft-aluminum foil facing
- A#5- Total Tender Price (Base bid) to <u>Replace</u> all "D1" type insulation with <u>Mineral Wool</u> type rigid board insulation with kraft-aluminum foil facing (R12).

Q#6- Proposed Alternate to replace all type "D1" insulation with type "D2"

A#6- Total Tender Price (Base bid) to <u>include</u> "D1" type insulation (<u>Mineral Wool</u> type rigid board insulation with kraft-aluminum foil facing (R12)). Alternate Price to be provided to substitute "D2" type insulation in place of "D1". - <u>See revised Bid Form attached.</u>

Q#7- What is required of existing insulation securement pins, prior to new work?

A#7- Existing pins to be removed, or otherwise modified to allow new materials to be installed, and to prevent damage to new jacketing. Cost to be included in Total Tender Price (base bid).

Q#8- On the site visit, it was proposed that the repairs required for the damaged ducting would be included in the existing contingency allowance, or defined under a separate contingency allowance, as the scope could not be determined before the removal of the existing insulation. Please clarify if this will be included under the existing contingency allowance, or define the new contingency value to carry.

A#8- Repairs to be covered in existing contingency allowance.

Q#9- Please confirm scaffolding can be used on the roof?

A#9 - Yes, scaffolding can be erected on the roof with required protection in place.

Q#10 - Type D1 Insulation – You mention secure with pins – as per the walkthrough can you please confirm if pins are required on the top side of the duct.

A#10 – Specification lists adhesive securement for horizontal top sides of ducts – no pins.

Q#11 - What is the Schedule for the Project – Using Flex Clad and or Venture Clad is a temperature dependent project.

A#11 - 60 working days from contract issuance.

Q#12 - - Submission Checklist

- a. Vendor Information Form to be fully completed
 - i. If we are already a registered vendor, do we need to complete this form again?

A#12 - Yes
