This addendum amends and forms part of the Tender Documents. The bidder shall insert the addendum behind the cover page of the Tender Documents.

**CLARIFICATION TO SPECIFICATIONS:**

As per the new Excess Soil's regulation the City underwent an Environmental Soils investigation for the project limits. The results of these test make up part of this tender and should be seen as an aid to the bidding process. The results and recommendations of the investigations should allow all contractors to bid accordingly, and determine where and how they would be able to move the soil based on these parameters. In the field, the soil parameters will vary slightly, but for the most part would remain true to what was shown in the report. In an instance where soil is uncovered that clearly does not match what the report identified, additional testing may need to be done (along with TCLP samples). Based on these results, if the only allowable soil removal plan is via landfill, the tender item for landfill deposit will be used ( for the newly discovered soil only). Tender item A – 58, is thus, only to be used in the circumstance described above, when soils are discovered that do not match the attached report and the soils were not already being hauled to a landfill. The City does not have a deposit site so all contractors must use the report to determine the appropriate deposal location at the time of bidding. The owner of the deposit location will be required to sign off that they understand and accept the excess soil. No soil tracking will be done at this time.

Except for the contents of this addendum, all other terms and conditions of this tender remain the same.
