Low noise construction activities during the hours of 8pm through to 6 am, to complete construction of a pedestrian bridge at the intersection with Cabana Road.
 - b. Scope of Exemption:
The intersection of Cabana Road with the Rt. Hon. Herb Gray Parkway footprint, easterly to Northway Avenue and on the Rt. Hon Herb Gray Parkway in the immediate vicinity of its intersection with Cabana Road/Todd Lane.
 - c. Duration of Exemption:
The request is for a period of 10 days with the option for renewal to be approved by the CAO through delegation of authority report.
