## **CAO APPROVAL**

The Chief Administrative Officer approved the following recommendation:

**Report Number: CAO 250/2023**

**Approved: Wednesday, September 20, 2023**

- I. THAT By-law 120-2023, adopted September 5, 2023, (the “**By-law**”) **BE AMENDED** as follows:
  - a) By **DELETING** the header of the By-law in its entirety and **INSERTING** the following in its place:

“A BY-LAW TO CLOSE, STOP UP AND CONVEY THE 4.57 METRE NORTH/SOUTH ALLEY AND THE 2.25 METRE EAST/WEST ALLEY, EAST OF OAK STREET, WEST OF CRAWFORD AVENUE AND NORTH OF TECUMSEH BOULEVARD WEST, CITY OF WINDSOR”
  - b) By **DELETING** “Paragraph 1” of the By-law in its entirety and **INSERTING** the following in its place:

“That the 4.57 metre east/west alley, and the 2.26 metre north/south alley, east of Oak Street, west of Crawford Avenue and north of Tecumseh Boulevard West, City of Windsor, more particularly described in Schedule “A” attached hereto forming part of this by-law be and the same is hereby closed and stopped up.”
- II. THAT the City Solicitor **BE DIRECTED** to prepare an amending by-law; and further, the Chief Administrative Officer and the City Clerk **BE AUTHORIZED** to sign all necessary documents approved as to form and content satisfactory to the City Solicitor, and that the matter **BE COMPLETED** electronically pursuant to By-law Number 366-2003.
