THAT the City Solicitor **BE DIRECTED** to prepare an amending by-law; and further, the Chief Administrative Officer and the City Clerk **BE AUTHORIZED** to sign all necessary documents approved as to form and content satisfactory to the City Solicitor or designate, and that the matter **BE COMPLETED** electronically pursuant to By-law Number 366-2003.
