




The Minister will be hosting all Canadians Seniors Minister in Hamilton, Ontario and offers to update the national ministers with this information during the conference.

- An audit of City priorities as outlined by the Checklist of Essential Features of Age-friendly Cities
- A signed-by-the mayor commitment to undertake the process
 1. Establishment of mechanisms to involve older people throughout the Age-friendly Cities cycle
 2. Development of a baseline assessment of the age-friendliness of the city
 3. Development of a 3 year city-wide action plan based on the findings of this assessment
 4. Identification of indicators to monitor progress against this plan.



Age-Friendly Windsor Project – Year 1
(funded by New Horizons for Seniors Program)


- **Goals:**
 1. To find out what Windsor residents feel is most important in an Age-friendly City.
 2. To obtain private/public sector stakeholders “buy-in” for an Age-friendly City.
 3. To establish a standing working group to continue with remaining phases of the project.



What do Windsor residents feel is most important?

HOW

1. Survey older residents in ward meetings with councillors present.
2. Use partner agencies to assist with surveying home-bound older adults.



Get Public/Private Sector “Buy-in”

HOW

1. Conduct 8 stakeholder meetings corresponding to 8 features/domains of Age-friendly Checklist and survey age-friendliness.
2. Recruit 2 “Champions” from each domain for ongoing support.
