

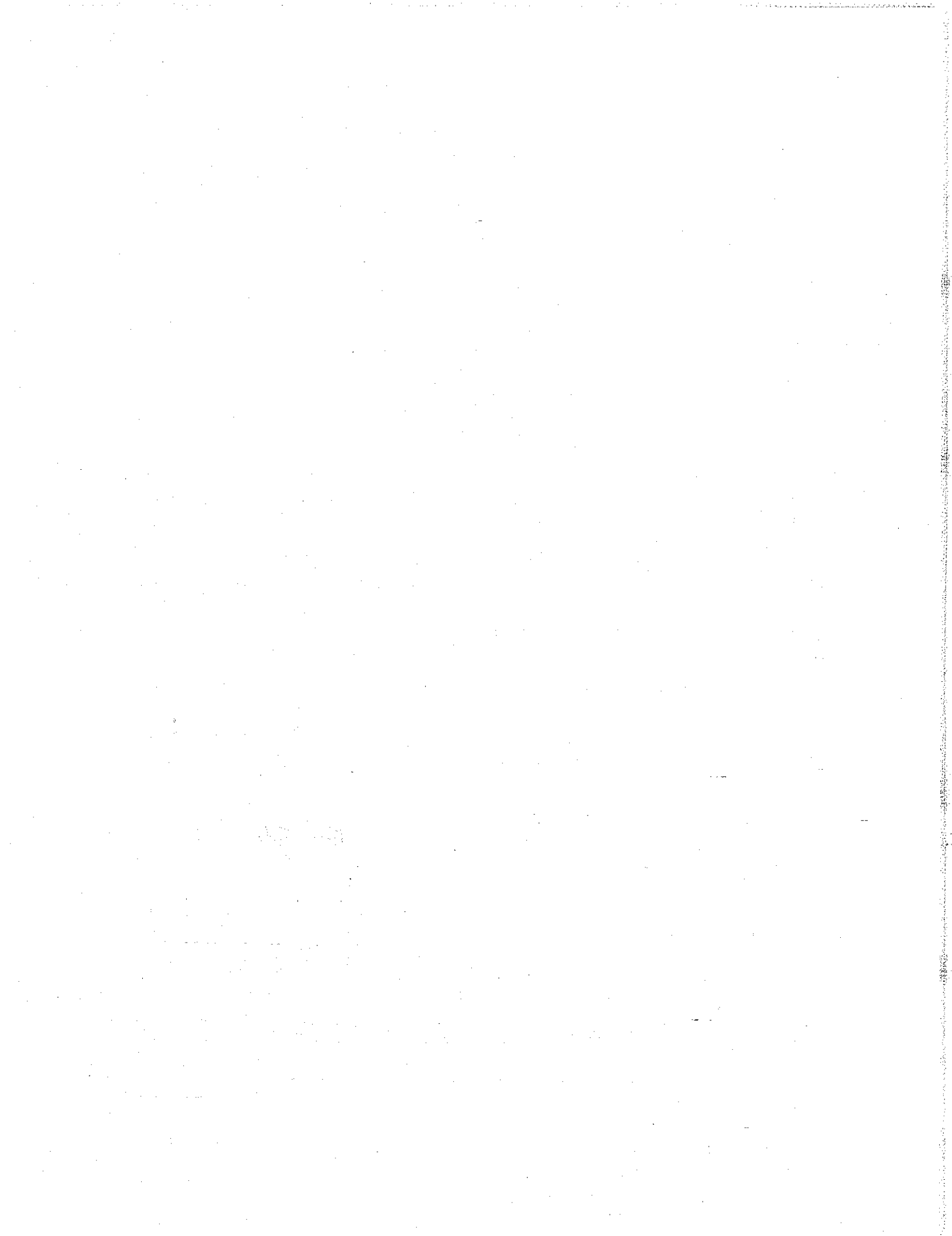

6. ADMINISTRATOR'S REPORT

A. Sirbu provides the following highlights of the Administrator's Report to the Committee of Management as follows:

- A mandate letter was received from the LHIN on March 20, 2015 with clear stipulation relating to the obligation of participating in the Integrated Assessment Record. The process of implementation will be further refined in collaboration with the LHIN.
- Huron Lodge continues to support the Ontario Association of Non-Profit Homes and Services for Seniors (OANHSS) in its goals and objectives of improving services to the non-profit sector of Long Term Care.
- Effective January 1, 2015, Huron Lodge is formally reinitiating the City established Integrated Attendance Management Policy. The Council approved Policy is based on a medical model to address absenteeism.

- Huron Lodge is embarking upon the modern approaches in dementia care. At this time, approximately 80% of all Huron Lodge staff has been trained in Gentle Persuasion Approach.

Moved by Councillor Sleiman, seconded by Councillor Gignac,

That the report of the Administrator of Huron Lodge dated May 25, 2015 entitled "Administrator's Report to the Committee of Management" relating to resident care, the Ministry of Health and Long Term Care, the Local Health Integration Network and other initiatives that impact the Long Term Care sector **BE RECEIVED** for information and **APPROVED** for the period from March 1, 2015 to May 31, 2015.

A. Sirbu provides an overview of "age at home" services. Councillor Marra notes Hotel Dieu Grace Hospital is developing a "care giver" college to provide care for those wishing to remain in their home.

A. Sirbu advises the average stay of residents (15 years ago) was five to six years and notes the average stay now is much less. She indicates Huron Lodge has the longest waiting list for admission in Windsor.
