

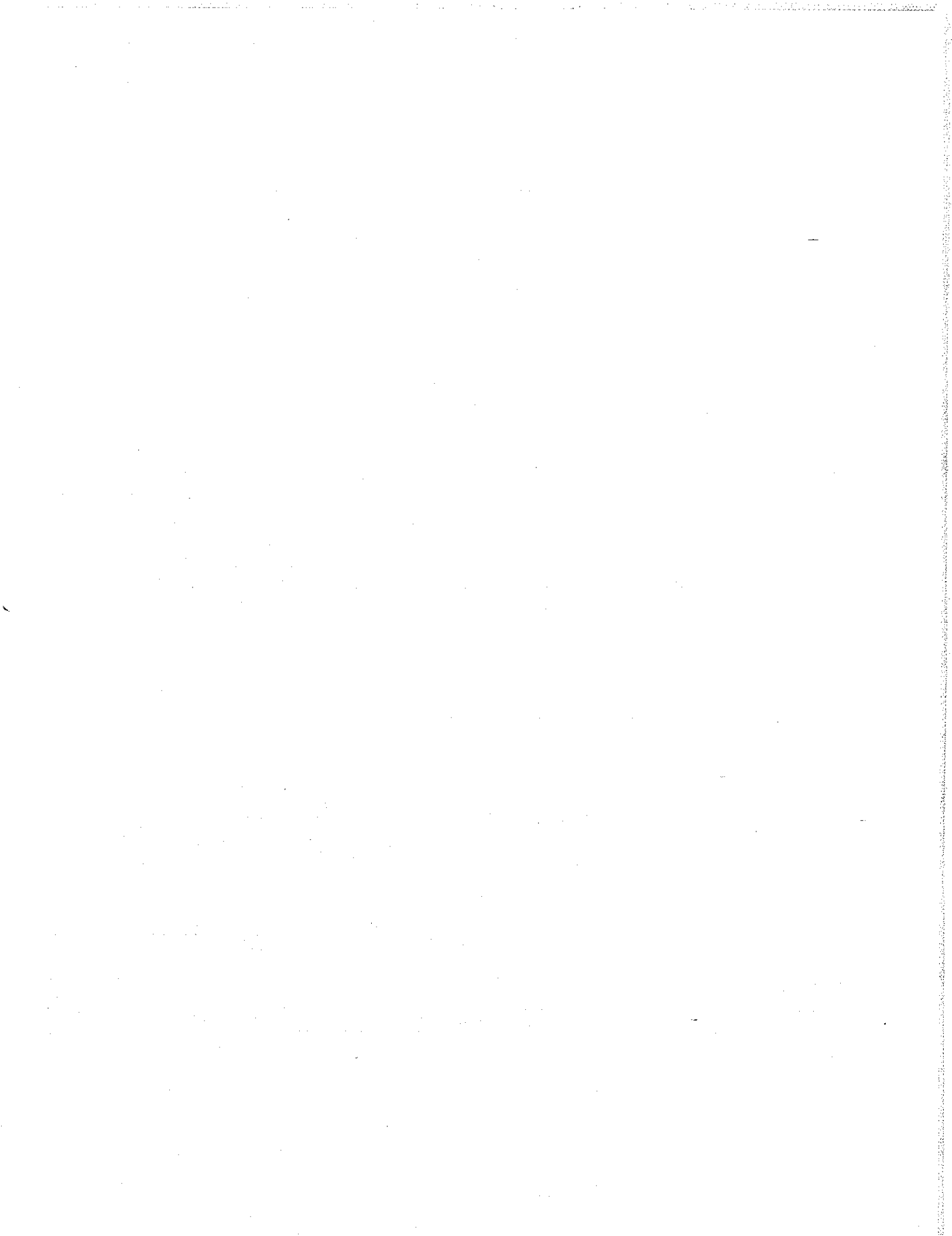

- 1) Description of Barrier Removal Project and how it promotes universal access to all persons with disabilities (include appropriate references to attitudinal, informational, physical, technological, architectural or policy barriers):

*Construction of the East Windsor Community Pool as an addition to the WFCU arena on McHugh Street. The design of the pool has included the principals of FADS and the Accessibility for Ontarians with Disabilities Act (AODA). The layout of the facility is barrier free, including the entrance into all pools through the use of accessible ramps in the lap pool and therapy pool and beach type entry to the children's splash pad. Colour cues are being used to assist people with visual impairments as warnings. The abovementioned measures are included in the budget for the addition as approved by Council. As the budget is fully committed additional items have been identified to be an*

*additional benefit to the community that would separate this pool as a leader in accessibility. These items are listed below:*

- 1. One (1) hydraulic lift change table in the family barrier free washroom \$11,083.10 (including HST)*
- 2. Two (2) water wheelchairs - \$4008.00 (including HST)*
- 3. One (1) portable lift to be used for the lap pool and therapy pool - \$9610.65 (including HST)*
- 4. Convert directional signage to braille – approximately \$3560.00 (including HST)*
- 5. Add floor tile strip around the pool ledges to provide a textural cue for persons with visual impairments - \$18,509.40 (including HST)*
- 6. One (1) shower chair - \$2715.90 (including HST)*

2) Provide a list of users and groups that will benefit from this barrier removal activity:

*All pool users, especially those using a wheelchair, with limited mobility or with visual impairments.*

*Caregivers.*

*The Life After Fifty community group currently leasing space in the WFCU centre directly adjacent to the new pool.*

*Any individuals looking to use the therapy pool for sports therapy, injuries, etc.*

3) Identify all partners in this project:

*The City of Windsor is solely funding the project being constructed by De Angelis Construction. However, the stakeholder list in the community is large, including user groups, potential rental partners, schools and swim clubs. We have been contacted by the John McGivney Children's Centre who have offered to speak in support of this initiative.*

5) Has this project been researched for best practises in creating accessibility?

Comments:

*Accessibility was identified as paramount as part of the City's requirements of this design-build project. The project team consulted with members of WAAC early on in the design. The staff at the Windsor International Aquatic and Training Centre (WIATC) were also consulted to determine what could improve upon the existing budgeted design. These consultations resulted in the above noted additional enhancements. This pool will primarily be used by the community as a whole and the goal is to provide a facility that is accessible to as many as possible. Should this request be successful, this facility will stand out in the community.*

6) Does the project meet or exceed Ontario Building Code or Windsor Facility Accessibility Design Standards (FADS) requirements? (Explain)

*The project in its current design not only meets OBC and FADS but exceeds them in certain areas. For example, the accessible ramps to the lap pool and therapy pool could have been replaced with a portable lift alone. However, we wanted to provide the most comfortable experience possible for users. We understand some users would prefer to transfer into a water wheelchair in the privacy of the barrier free washroom and use the ramps in the pool rather than be lifted into the pool in front of the public. However, the additional portable lift we are asking for will provide options to users.*

7) Does the vendor/supplier/designer/contractor of this project support the principles of full accessibility for people with disabilities?

Comments:

*De Angelis construction built the WIATC with accessibility in mind. They are eager to improve upon that design for this community pool and have been working alongside City staff to do so. Myrtha pools, the supplier of all three pools, are internationally recognized for their pools with accessibility as a standard.*
