THAT the Chief Administrative Officer and City Clerk **BE AUTHORIZED** to execute any agreements, declarations or approvals that may result from receiving the Municipality Climate Action Offer from Enbridge Gas satisfactory in technical content to the Executive Director, Economic Development & Climate Change, financial content to the City Treasurer and in form to the City Solicitor; and,

THAT the Chief Administrative Officer **DELEGATE** signing of all claims and applicable reports and other such documents, as required as part of receiving the Municipality Climate Action Offer from Enbridge Gas to the Executive Director, Economic Development & Climate Change, subject to financial content approval from the area's Financial Planning Manager or their designate.
