- IV) THAT the Chief Administrative Officer and City Clerk **EXECUTE** any agreements, declarations or approvals and any other such documents required resulting from North-South Environmental receiving funding from HSP, subject to all documentation being satisfactory in form to the City Solicitor, in technical content to the Executive Director, Parks, Recreation and Facilities, and in financial content to the City Treasurer or designates; and,
- V) THAT the Chief Administrative Officer **AUTHORIZE** the signing of all claims and applicable reports and other such documents as required as part of North-South Environmental receiving funding from HSP, to the Executive Director, Parks, Recreation and Facilities subject to all documentation being satisfactory in financial content to the area's Financial Planning Manager, or designates.
