THAT the Commissioner, Human and Health Services or their authorized designate **BE AUTHORIZED** to sign and submit the necessary submission(s) in the required manner to secure funding in response to the additional funding related to the Canada-Ontario Housing Benefit (COHB), One-Time Shelter Expansion / Encampment Response Initiative Funding under the Homelessness Prevention Program ("HPP") and the Last Mile Funding Initiatives for "Ready to Build" Housing Projects under Canada Ontario Community Housing Initiative — Ontario Priorities Housing Initiative ("COCHI-OPHI") provided that they are satisfactory in financial content to the City Treasurer, and in technical content to the Executive Director of Housing & Children's Services; and further

THAT in the event the City of Windsor is allocated funds under one or more of the following: Canada-Ontario Housing Benefit (COHB), One-Time Shelter Expansion / Encampment Response Initiative Funding under the Homelessness Prevention Program (HPP) and the Last Mile Funding Initiatives for "Ready to Build" Housing Projects under the under Canada Ontario Community Housing Initiative — Ontario Priorities Housing Initiative (COCHI-OPHI), that the Executive Director of Housing and Children's Services or their authorized designate **BE AUTHORIZED** to confirm to the Ministry of Municipal Affairs and Housing, that the City of Windsor as Service Manager will deliver one or more of the initiatives and further participate in and deliver any subsequent and/or additional funding allocations from MMAH and/or provincial ministry

THAT the Chief Administrative Officer and City Clerk or their authorized designates **BE AUTHORIZED** to execute the Transfer Payment Agreement between the City of Windsor and MMAH and/or provincial ministry having authority over the project(s) and any related amendments, extensions and subsequent releases, including any current or subsequent related programs and related program extensions, provided that the Transfer Payment Agreement and any related amendments, extensions and subsequent releases are in a form satisfactory to the City Solicitor, satisfactory in financial content to the City Treasurer, and in technical content to the Executive Director of Housing & Children's Services; and further

THAT the Executive Director of Housing and Children's Services or their authorized designate **REPORT BACK** to Council in 2025.
