- I. THAT the CAO **APPROVE** the award of Tender 04-24, Lauzon Parkway Reconstruction— Hawthorne Drive to Cantelon Drive, to the lowest compliant bidder, J&J Lepera Infrastructures Inc. in the amount of \$15,187,000.00 plus HST; and,
- II. THAT the CAO and City Clerk **EXECUTE** an agreement with the lowest compliant bidder, J&J Lepera Infrastructures Inc., in the amount of \$15,187,000.00 plus HST, being satisfactory in form to the City Solicitor, satisfactory in technical content to the City Engineer, and in financial content to the City Treasurer; and,
- III. THAT CAO **APPROVE** the amendment of the agreement (RFP No. 39-21) with Dillon Consulting Limited, approved through CR392/2021, by increasing the upset limit by an additional \$102,960.00 (excluding HST) for a revised cumulative upset limit totalling \$506,560.00 (excluding HST); for additional consulting services of contract administration and engineering assistance for the Lauzon Parkway Reconstruction Hawthorne Drive to Cantelon Drive; and,
- IV. THAT the CAO and City Clerk **BE AUTHORIZED** to amend the agreement with Dillon Consulting Limited, to include the additional scope of work related to contract administration and engineering assistance in the total additional amount of \$102,960.00 plus HST, satisfactory in form to the City Solicitor, satisfactory in technical content to the City Engineer, and in financial content to the City Treasurer; and,
- V. THAT the CAO **AUTHORIZE** Administration to use contingency amounts available in the Lauzon Parkway Reconstruction Hawthorn Drive to Cantelon Drive project budget as detailed herein, for any amendment(s) or change
