The Chief Administrative Officer approved the following recommendation:

**Report Number: CAOP 65/2025**

**Approved: Thursday, September 11, 2025**

THAT the Chief Administrative Officer **APPROVE EXTENSIONS** of existing service agreements with:

Total Power Limited, for complete maintenance services in accordance with the attached hourly rate schedules, for the CHP units at WFCU Center & WIATC, to be funded by Maintenance and Equipment Replacement Reserve Fund 222; and,

2G Energy Corp., for complete maintenance services in accordance with the attached hourly rate schedules, for the CHP unit at Huron Lodge LTC, to be funded by Maintenance and Equipment Replacement Reserve Fund 222; and,

THAT the Purchasing Manager **BE AUTHORIZED** to **AMEND** the Contract Purchase Orders to Total Power Limited not to exceed \$189,120 (excluding HST) annually and to 2G Energy Corp. not to exceed \$52,000 (excluding HST) annually, for the final option year renewal term in accordance with the terms of RFP 52-19 for the provisions of the services stated above, satisfactory in financial content to the City Treasurer, and in technical content to the Senior Manager of Asset Planning; and,

THAT the Chief Administrative Officer **AMEND** the second recommendation in CAOP 146/2020 to include a multi-year agreement provisions that was included within the body of the report: THAT the Purchasing Manager **BE AUTHORIZED** to issue Contract Purchase Orders to Total Power Limited not to exceed \$189,120 annually (excluding HST) *for a two-year term plus three one-year renewal terms* and to 2G Energy Corp not to exceed \$52,000 annually (excluding HST), *for a two-year term plus three one-year renewal terms* for the provisions of the services stated above, satisfactory in financial content to the City Treasurer, and in technical content to the Senior Manager of Asset Planning.
