### **BACKGROUND:**

a) Windsor City Council, at its meeting held January 27, 2025 adopted the following:

*Moved by: Councillor Renald Agostino  
Seconded by: Councillor Kieran McKenzie*

*Decision Number: B21/2025  
That with regard to the proposed "Elimination of Tunnel Bus/Special Events Service", that the one-way fare for special events and regular tunnel bus service **BE INCREASED TO \$20.00** per person each way; and,*

*That funding in the amount of \$791,300 **BE APPROVED** and **BE FUNDED** through the 2025 tax levy.  
Carried.*

*At the request of Councillor Gignac, a recorded vote is taken.*

- b) Mayor Dilkens issued the **attached** Mayoral Decision MD06-2025 in which he has exercised his authority to veto an amendment made by City Council at its meeting held January 27, 2025.
- c) Within 15 days of the Mayor's veto date (being February 6, 2025), Council may meet to override the mayoral veto, through a 2/3 vote of Council. The legislation provides the Mayor with the option to vote on this matter. If the Mayor chooses to vote, then 8/11 votes are required for the override. If the Mayor chooses not to vote, then 7/10 votes are required for the override.

**Mayoral Decision MD 06-2025**

I, Drew Dilkens, Mayor of the City of Windsor, by virtue of S. 284.16(4) of the *Municipal Act, 2001*, and *O.Reg. 530/22* thereunder, hereby exercise my authority to veto the amendment made by City Council at its meeting held January 27, 2025 with respect to the addition of the tunnel bus service to the 2025 City of Windsor budget.

This veto is being issued for the following reasons:

1) This service acts as an economic development engine for the City of Detroit. The City of Windsor sees almost no economic activity originating from Detroit through this service. At this time, our City and our Country are under economic attack by the President of The United States who is threatening 25% tariffs on Canadian made goods. While our cross-border bond with the City of Detroit remains strong and is important to us, as Mayor, I cannot in good conscience have Windsor taxpayers subsidize transit service to a country that is threatening our livelihood.

2) City Council's decision to increase fares to \$20 per person each way, will significantly undermine tunnel bus usage and lower total revenue. This fare increase makes the tunnel bus service more expensive than driving a car to Detroit (including the cost of tolls and parking fees). The expected revenue decrease will lead to a greater overall loss in the tunnel bus operation. I acknowledge and appreciate City Council's attempt to increase revenue by raising the fare, however I sincerely believe this will further undermine the 2025 budget.

This Mayoral Decision comes into effect on February 6, 2025.

BY-LAW NUMBER 29-2025

A BY-LAW TO CONFIRM PROCEEDINGS OF THE COUNCIL OF THE CORPORATION OF THE CITY OF WINDSOR AT ITS SPECIAL MEETING HELD ON THE 21<sup>ST</sup> DAY OF FEBRUARY, 2025

3. The Mayor and the City Clerk are authorized and directed to execute all documents necessary in that behalf and to affix thereto the seal of The Corporation of the City of Windsor.

This by-law shall come into force and take effect on the day of the final passing thereof.
