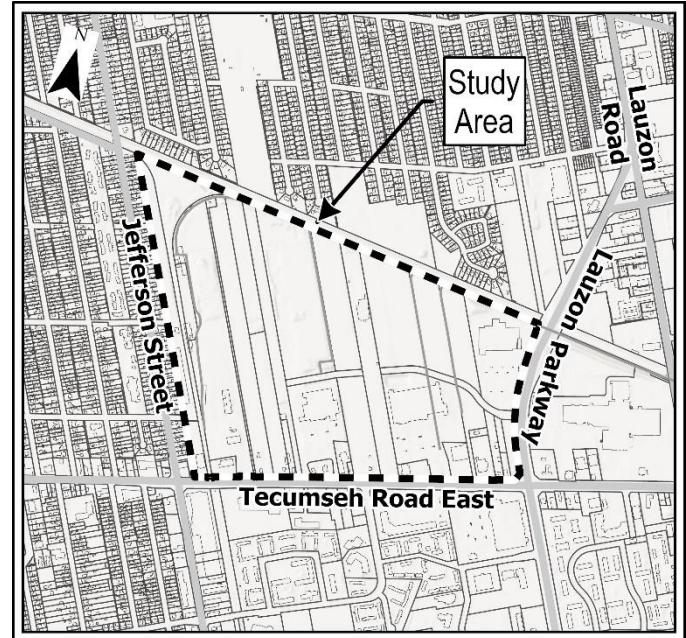


Notice of Study Completion

Forest Glade North Servicing Environmental Assessment

The Study: The City of Windsor has initiated a Municipal Class Environmental Assessment to evaluate alternative ways to provide municipal services to the Forest Glade North Secondary Plan area. These services will include sanitary sewers, a stormwater management system, and new roadways. The preferred alternative for the roadways is to extend Catherine Street and Roseville Garden Drive within a 22 m right-of-way (ROW). The roads will have two travel lanes and a two-way centre turn lane, as well as a multi-use trail on one side of Catherine Street and Roseville Garden Drive. The preferred alternative for stormwater is to establish one regional stormwater management pond in the northcentral portion of the study area. The preferred alternative for sanitary services is to extend the current sanitary sewer system with a connection at Lauzon Parkway.



The Process: The project was conducted in accordance with the planning and design processes for 'Schedule B' wastewater and stormwater projects and 'Schedule C' collector road projects, as outlined in the Municipal Class Environmental Assessment (2023), which is approved under the Environmental Assessment Act. The MCEA process includes consultation with agencies, stakeholders, Indigenous communities, and public; an evaluation of alternative solutions to address the problem; alternative design concepts for the preferred solution; an assessment of potential environmental impacts; and identification of reasonable measures to mitigate any potential adverse impacts. A Notice of Study Commencement and Public Information Centre (PIC) inviting public input was published on November 8th, 2024, and the PIC was held on November 26th, 2024.

Environmental Study Report: An Environmental Study Report (ESR) has been prepared to document the planning and decision-making process for this Study. By this notice, the ESR is being placed on the public record and will be available for a 30-day review period starting February 14th, 2025, and ending March 15th, 2025, to meet requirements of the MCEA process. An electronic copy of the ESR is available for viewing on the project webpage at windsoreas.ca.
