### Definitions

**Base year:** the year of the income tax return we use to calculate your benefit

**Payment period:** the 12-month period that begins in July and runs through June of the next year

**Family net income:** the net income from your tax return and, if applicable, your spouse's or common-law partner's return, **minus** any universal child care benefit (UCCB) and registered disability savings plan (RDSP) income you received, **plus** any UCCB and RDSP amounts you repaid during the tax year and any amount you claimed for total split income

**If you want to register a formal dispute:**

- go to [canada.ca/cra-complaints-disputes](http://canada.ca/cra-complaints-disputes); you have 90 days from the date of this notice to register your dispute.
